

**MEMORANDUM OF UNDERSTANDING
ON THE COLLABORATION

and

**SHEMBEKAR AQUA-AGRO SERVICES, LATUR,
REPRESENTED BY ITS DIRECTOR MRS. V. V. SHEMBEKAR**

Together join in issuing the following agreement to promote a closer regional cooperation between the two organizations and for the better understandings between the people of India through research, training and extension activities interchange.

This memorandum of understanding (MoU) will serve as a general framework for both the organizations. Based on mutual understanding, Director, Shembekar Aqua-Agro Services, Latur and Principal, Dayanand Science College, Latur are designated to coordinate the application of this agreement in the best interest of both the organization.

WHEREAS, the two organization share common interests in research, training, and extension activities (Lab to land practices) with a regional and global perspective.

BE IT MUTUALLY RESOLVED AND AGREED that the cooperative relationship shall be carried out by both the organizations and following terms have been accepted by both the organizations involved in this MoU:

1) Student / Staff training: Shembekar Aqua-Agro Services (SAAS), Latur will provide training to students / staff of Department of Zoology and Fishery Science, Dayanand Science College, Latur through following means –

- a. Training and exposure visits will be given to the students studying in Department of Fishery Science as well as Department of Zoology to understand the working methodology of Aquaculture and develop the interest in Fish farming among the students.
- b. Field demonstration of various ongoing training and field projects for the students of Department of Fishery Science and Zoology will be arranged by Shembekar Aqua-Agro Services (SAAS), Latur.
- c. Special Bio-entrepreneurship development/ training programs will be arranged by SAAS for aspirant students.

2) **Technical Assistance:** Dayanand Science College, Latur agrees to extend technical assistance to Shembekar Aqua-Agro Services (SAAS), Latur for improvement in the process of development and production of the products such as fish feed development, fish breeding techniques, bio-control agents and biofertilizers including strain isolation, modification and adaptation, compost production and its quality improvement. Also the volunteers from SAAS will be provided training on all the ongoing aspects carried out at Department of Fishery Science, Dayanand Science College, related to the work being carried out for SAAS.

3) Also through this MoU Dayanand Science College, Latur agrees to carry out all the QC (Quality Control) related activities of the projects proposed and being implemented by Shembekar Aqua-Agro Services (SAAS), Latur at the Premises of Department of Fishery Science, Dayanand Science College, Latur and will assist technically for better and quality product development.

Note: All the expenses being incurred for carrying out the activities of the collaborator organization in the MoU shall be barrowed by the respective counterpart only.


